

Contracts Register

The Procurement Reform (Scotland) Act 2014 requires public bodies to maintain a contract register. The contracts contained in the register are any contracts entered into as a result of a regulated procurement. The public body is also obliged to make the information publicly available.

To fulfil its duty under the Act Audit Scotland has published the following information:
