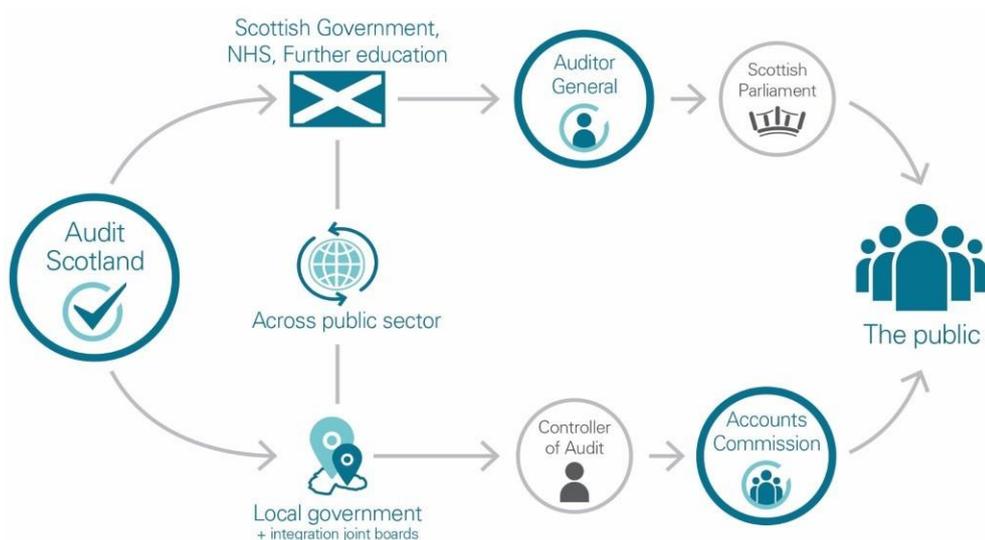

Who we are

The Auditor General, the Accounts Commission and Audit Scotland work together to deliver public audit in Scotland:

- The Auditor General is an independent crown appointment, made on the recommendation of the Scottish Parliament, to audit the Scottish Government, NHS and other bodies and report to Parliament on their financial health and performance.
- The Accounts Commission is an independent public body appointed by Scottish ministers to hold local government to account. The Controller of Audit is an independent post established by statute, with powers to report directly to the Commission on the audit of local government.
- Audit Scotland is governed by a board, consisting of the Auditor General, the chair of the Accounts Commission, a non-executive board chair, and two non-executive members appointed by the Scottish Commission for Public Audit, a commission of the Scottish Parliament.



About us

Our vision is to be a world-class audit organisation that improves the use of public money.

Through our work for the Auditor General and the Accounts Commission, we provide independent assurance to the people of Scotland that public money is spent properly and provides value. We aim to achieve this by:

- carrying out relevant and timely audits of the way the public sector manages and spends money
- reporting our findings and conclusions in public
- identifying risks, making clear and relevant recommendations.

Risks and planned work

1. This annual audit plan contains an overview of the planned scope and timing of our audit which is carried out in accordance with International Standards on Auditing (ISAs), the [Code of Audit Practice](#), and guidance on planning the audit. This plan sets out the work necessary to allow us to provide an independent auditor's report on the annual accounts and meet the wider scope requirements of public sector audit.

2. The wider scope of public audit contributes to assessments and conclusions on financial management, financial sustainability, governance and transparency and value for money.

3. The public health crisis caused by the coronavirus disease 2019 (COVID-19) pandemic has had a significant and profound effect on every aspect of Scottish society. Public services have been drastically affected, requiring immediate changes to the way they are provided. The impact on public finances has been unprecedented, which has necessitated both the Scottish and UK governments providing substantial additional funding for public services as well as support for individuals, businesses and the economy. It is likely that further financial measures will be needed and that the effects will be felt well into the future.

4. Public audit has an important contribution to the recovery and renewal of public services. The Auditor General, the Accounts Commission and Audit Scotland are responding to the risks to public services and finances from COVID-19 across the full range of audit work including annual audits and the programme of performance audits. Audit Scotland views 2020/21 as a transitional year, leading in future to audit timetables which were possible before COVID-19. The well-being of audit teams and the delivery of high-quality audits remain paramount. Maintaining a pragmatic and flexible approach will enable change at short notice as new issues emerge, or current risks change in significance. Where this impacts on annual audits, an addendum to this annual audit plan may be necessary.

Adding value

5. We aim to add value to sportscotland Group and Lottery Fund through our external audit work by being constructive and forward looking, by identifying areas for improvement and by recommending and encouraging good practice. In so doing, we intend to help sportscotland Group and Lottery Fund promote improved standards of governance, better management and decision making and more effective use of resources.

Audit risks

6. Based on our discussions with staff, attendance at committee meetings and a review of supporting information we have identified the following significant risks for sportscotland Group and Lottery Fund sportscotland Group and Lottery Fund. We have categorised these risks into financial statements risks and wider dimension risks. The key audit risks, which require specific audit testing, are detailed in [Exhibit 1](#).

uncertain market and financial conditions surrounding the pandemic, their valuation now carries a higher degree of subjectivity than would apply in normal circumstances. For pension valuations, although no additional uncertainty was highlighted the valuation will need to be monitored in 20/21 to assess whether the fluctuation in value is material.

Given the nature of these valuations, the application of estimation and judgement over these areas poses a risk of material misstatement for 20/21.

- We will commission independent valuations for our buildings in line with our previous rolling plan for property valuations.

Wider dimension risks

5 Financial sustainability

sportscotland Group and Lottery Fund continue to face uncertainty over funding, partially due to the unpredictable nature of the performance of the Lottery Fund, as well as the unknown long-term impact of the ongoing Covid-19 pandemic.

Although a break-even position is forecast for 2020/21, it is noted that a Going Concern uncertainty was disclosed in the 2019/20 Trust Company accounts and there is a risk that financial balance across the group may not be achievable in the medium to long term.

- The risk is recognised in the corporate risk register. sportscotland carries out detailed financial planning throughout the year, based on the assumptions available from Scottish Government and DCMS.
- sportscotland prepares a quarterly review of National Lottery income and scenario planning and this is used to update financial planning as required.
- National Lottery income has held up well in 2020-21 compared to the previous year.
- Scottish Government income as announced in the draft budget for 2021-22 will be the same as 2020-21.
- Review and assess the adequacy and robustness of medium to long-term financial plans, as well as the short term action plan issued to respond to the Covid-19 pandemic..

6 Governance and transparency – financial regulations and workforce planning

sportscotland has sound governance arrangements in place, however we have identified slippage in review of governance documentation including financial regulations and workforce planning.

sportscotland does not have a Workforce Plan. There is a risk that without effective and up-to-date workforce planning, the organisation does not efficiently manage its

staffing needs, or that it will be under-prepared to respond to changing needs or demands or conduct any restructuring should it be required.

reviewed by the Internal Auditors in 2019-20, looking specifically at the Trust Company sites and its links into Head Office. Substantial assurance was issued. Work is ongoing to fully document the existing financial control processes.

- The Fraud Toolkit will be updated as part of the current review of all legal policies.
- sportscotland has an Establishment Report in place which provides analysis of the current workforce/ organisation structure including vacancies; and staffing budgets and staffing profile (age, gender, grade etc).
- Our draft People Strategy and associated action plan is being developed supported by our internal auditors. Management will consider developing a resourcing strategy / workforce plan as part of this action.

7 Governance and transparency – changing working environment due to Covid-19

Due to the Covid-19 pandemic, sportscotland moved to remote working in March 2020 with short notice, and there is a risk that this has resulted in changes to the control environment.

- A significant majority of sportscotland staff were used to working remotely as part of their normal working arrangements pre-COVID.
- The move to the homeworking for all worked smoothly and the IT infrastructure has proved resilient.
- Normal control procedures have been maintained where possible. Some adjustments have been made, such as accepting e-mail approvals rather than signatures on invoices.
- Carry out walkthrough testing during the interim audit to confirm whether there have been any changes which weaken the key controls.
- Where any weakened controls are identified, we will increase sample sizes for substantive testing.

Reporting arrangements

- 7.** Audit reporting is the visible output for the annual audit. All audit outputs as detailed in [Exhibit 2](#) will be published on our website: www.audit-scotland.gov.uk.
- 8.** Matters arising from our audit will be reported on a timely basis and will include agreed action plans. Draft management reports will be issued to the relevant officers to confirm factual accuracy.
- 9.** We will provide an independent auditor's report to sportscotland Group and Lottery Fund, the Scottish Parliament and the Auditor General for Scotland setting out our opinions on the annual accounts. We will provide the Accountable Officer and Auditor General for Scotland with an annual report on the audit containing observations and recommendations on significant matters which have arisen during the audit.
- 10.** Under the Public Finance and Accountability (Scotland) Act 2000 there is a requirement for the resource account of the Scottish Government to be presented to Parliament within nine months of the financial year – end, i.e. 31 December. Management are required to submit their audited financial statements by 31 October to meet the consolidation timetable.

Audit fee

- 11.** The proposed audit fee for the 2020/21 audit of sportscotland Group and Lottery Fund is £48,940 (2019/20 £48,176). In determining the audit fee we have taken account of the risk exposure of sportscotland Group and Lottery Fund, the planned management assurances in place and the level of reliance we plan to take from the work of internal audit. Our audit approach assumes receipt of the unaudited annual accounts, with a complete working papers package on 7 June 2021.
- 12.** Where our audit cannot proceed as planned through, for example, late receipt of unaudited annual accounts, a supplementary fee may be levied. An additional fee may also be required in relation to any work or other significant exercises out with our planned audit activity.

Responsibilities

Audit Committee and Accountable Officer (or equivalent)

- 13.** Audited bodies have the primary responsibility for ensuring the proper financial stewardship of public funds, compliance with relevant legislation and establishing effective arrangements for governance, propriety and regularity that enable them to successfully deliver their objectives.

14. The audit of the annual accounts does not relieve management or the Audit and Risk Committee as those charged with governance, of their responsibilities.

Appointed auditor

15. Our responsibilities as independent auditors are established by the Public Finance and Accountability (Scotland) Act 2000 and the Code of Audit Practice (including supplementary guidance) and guided by the Financial Reporting Council's Ethical Standard.

16. Auditors in the public sector give an independent opinion on the financial statements and other information within the annual accounts. We also review and report on the arrangements within the audited body to manage its performance, regularity and use of resources. In doing this, we aim to support improvement and accountability.

Audit scope and timing

Annual accounts

17. The annual accounts, which include the financial statements, will be the foundation and source for most of the audit work necessary to support our judgements and conclusions. We also consider the wider environment and challenges facing the public sector. Our audit approach includes:

- understanding the business of sportscotland Group and Lottery Fund and the associated risks which could impact on the financial statements
- assessing the key systems of internal control, and establishing how weaknesses in these systems could impact on the financial statements
- identifying major transaction streams, balances and areas of estimation and understanding how sportscotland Group and Lottery Fund will include these in the financial statements
- assessing the risks of material misstatement in the financial statements
- determining the nature, timing and extent of audit procedures necessary to provide us with sufficient audit evidence as to whether the financial statements are free of material misstatement.

18. We will give an opinion on whether the financial statements:

- give a true and fair view of the state of affairs of sportscotland Group and Lottery Fund as at 31 March 2021 and of their income and expenditure for the year then ended;
- have been properly prepared in accordance with the financial reporting framework.
- have been prepared in accordance with the requirements of the Royal Charter / National Lottery etc. Act 1993 and directions made thereunder by the Scottish Ministers.

19. The group financial statements include the balances and transactions of sportscotland combined with those of the related Trust Company. Wylie & Bisset will undertake the audit of the Trust Company for 2020/21. In order to arrive at our opinion on the financial statements of the Group, we will obtain such assurances as are necessary from Wylie & Bisset on their audit of the Trust Company.

Information accompanying the financial statements

20. We also review and report on statutory other information published within the annual accounts including the management commentary, annual governance statement and the remuneration report. We give an opinion on whether these have been compiled in accordance with the appropriate regulations and frameworks in our independent auditor's report.

21. We also review the content of the annual report for consistency with the financial statements and with our knowledge. We report any uncorrected material misstatements in statutory other information.

Materiality

22. We apply the concept of materiality in planning and performing the audit. It is used in evaluating the effect of identified misstatements on the audit, and of any uncorrected misstatements, on the financial statements and in forming our opinions in the independent auditor's report.

23. We calculate materiality at different levels as described below. The calculated materiality values for sportscotland Group and Lottery Fund are set out in [Exhibit 3](#).

Internal audit

25. Internal audit is provided by Scott-Moncrieff. As part of our planning process we carry out an annual assessment of the internal audit function to ensure that it operates in accordance with the main requirements of the Public Sector Internal Audit Standards (PSIAS). ISA (UK) 610 requires an assessment on whether the work of the internal audit function can be used for the purposes of external audit. This includes:

- the extent to which the internal audit function's organisational status and relevant policies and procedures support the objectivity of the internal auditors
- the level of competence of the internal audit function
- whether the internal audit function applies a systematic and disciplined approach, including quality control.

26. We will report any significant findings to management on a timely basis.

Using the work of internal audit

27. International Auditing Standards require internal and external auditors to work closely together to make best use of available audit resources. We seek to rely on the work of internal audit wherever possible to avoid duplication. We will consider aspects of the work of internal audit as their findings are made available however, due to the timing and scope of the work, no formal reliance is planned.

Audit dimensions

28. Our audit is based on four audit dimensions that frame the wider scope of public sector audit requirements as shown in [Exhibit 5](#).

Financial sustainability

29. As auditors we consider the appropriateness of the use of the going concern basis of accounting as part of the annual audit. We will also comment on financial sustainability in the longer term. We define this as medium term (two to five years) and longer term (longer than five years) sustainability. We will consider:

- the effectiveness of financial planning in identifying and addressing risks to financial sustainability in the short, medium and long term
- the appropriateness and effectiveness of arrangements in place to address any identified funding gaps

Financial management

30. Financial management is concerned with financial capacity, sound budgetary processes and whether the control environment and internal controls are operating effectively. We will consider:

- whether arrangements are in place to ensure systems of internal control are operating effectively
- whether sportscotland can demonstrate the effectiveness of their budgetary control systems in communicating accurate and timely financial performance
- how sportscotland has assured themselves that their financial capacity and skills are appropriate
- whether there are appropriate and effective arrangements in place for the prevention and detection of fraud and corruption.

Governance and transparency

31. Governance and transparency is concerned with the effectiveness of scrutiny and governance arrangements, leadership and decision – making and transparent reporting of financial and performance information. We will consider:

- whether sportscotland Group and Lottery Fund can demonstrate that the governance arrangements in place are appropriate and operating effectively.
- whether there is effective scrutiny, challenge and transparency on the decision-making and finance and performance reports.
- the quality and timeliness of financial and performance reporting.

Value for money

32. Value for money refers to using resources effectively and continually improving services. We will review, conclude and report on whether sportscotland, including the Lottery Fund, can demonstrate :

- value for money in the use of resources
- there is a clear link between money spent, output and outcomes delivered.
- that outcomes are improving.
- there is sufficient focus on improvement and the pace of it.

Best Value

33. The Accountable Officer of sportscotland Group and Lottery Fund has a duty to ensure arrangements are in place to secure best value. We will review and report on these arrangements.

34. We are required to consider, at least once during our audit appointment, how equalities are advanced by each audited body and we will carry out work in this area during the 2020/21 audit of sportscotland Group and Lottery Fund.

Independence and objectivity

35. Auditors appointed by the Accounts Commission or Auditor General must comply with the Code of Audit Practice and relevant supporting guidance. When auditing the financial statements auditors must also comply with professional standards issued by the Financial Reporting Council and those of the professional accountancy bodies. These standards impose stringent rules to ensure the independence and objectivity of auditors. Audit Scotland has robust arrangements in place to ensure compliance with these standards including an annual “fit and proper” declaration for all members of staff. The arrangements are overseen by the Director of Audit Services, who serves as Audit Scotland’s Ethics Partner.

36. The engagement lead (i.e. appointed auditor) for sportscotland Group and Lottery Fund is Alasdair Craik, Senior Audit Manager. Auditing and ethical standards require the appointed auditor to communicate any relationships that may affect the independence and objectivity of audit staff. We are not aware of any such relationships pertaining to the audit of sportscotland Group and Lottery Fund.

Quality control

37. International Standard on Quality Control (UK and Ireland) 1 (ISQC1) requires that a system of quality control is established, as part of financial audit procedures, to provide reasonable assurance that professional standards and regulatory and legal requirements are being complied with and that the independent auditor’s report or opinion is appropriate in the circumstances.

38. The foundation of our quality framework is our Audit Guide, which incorporates the application of professional auditing, quality and ethical standards and the Code of Audit Practice (and supporting guidance) issued by Audit Scotland and approved by the Auditor General for Scotland. To ensure that we achieve the required quality standards Audit Scotland conducts peer reviews and internal quality reviews. Additionally, the Institute of Chartered Accountants of Scotland (ICAS) have been commissioned to carry out external quality reviews.

39. As part of our commitment to quality and continuous improvement, Audit Scotland will periodically seek your views on the quality of our service provision. We welcome feedback at any time and this may be directed to the engagement lead.
